



“Overnight Camper” WAIVER of Liability

This form MUST be completed by the Parents/Guardians of all FSI Campers since they are staying overnight. NO camper will be allowed to stay overnight without this waiver – NO EXCEPTIONS!

1. The participant (which includes the participant and, if under 18 or infirmed, the parent or legal guardian of the participant) hereby acknowledges that any program including physical exertion, and any overnight program away from participant’s home, contains some element of risk of loss of property, and some risk of injury, possibly of a serious nature, including, but not limited to, the risk of death. It is expressly agreed by the participant that he/she understands the risk of injury inherent in any such physical and/or overnight program and that the participant undertakes such program at his/her sole risk and discretion. I understand that the signing of this waiver of liability includes transportation to, from or in connection with the Fellowship Football camp. Fellowship Football, its parent company FELLOWSHIP SPORTS, Incorporated (FSI), its officers, officials, directors, staff, volunteers, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, venue and, if applicable, owners and lessors of premises used to conduct the event (“Releases”), shall not be liable for any injury or damage to the participant, or property of the participant, or be subject to any claim or demand for injury or damages.
2. The participant warrants that he/she has no disability, impairment or ailment preventing such person from engaging in active or passive physical exertion or which will be detrimental to the health of such person if he/she does undertake, or participate in, such activity.
3. The participant acknowledges and agrees that Fellowship Sports, Incorporated will rely on the foregoing warranty, that FELLOWSHIP SPORTS, INC. has no obligation or duty to determine the participant’s physical condition, that if any fitness assessment or testing is performed by or on behalf of Fellowship Sports, Incorporated it is solely for informational, and not diagnostic, purposes, and that FELLOWSHIP SPORTS, INC. shall not be subject to any claim, demand, injury or damage whatsoever as a result of such fitness assessment or testing.
4. The participant agrees to comply with all rules, terms, and conditions of participation in the overnight camp and shall not undertake or participate in any unsupervised activity which may be hazardous to the participant or others. The participant shall immediately report to Fellowship Sports, Incorporated any such dangerous activity or any other hazardous or dangerous conditions noted.
5. It is understood by all parties involved that the participants of the Fellowship Sports, Inc. will be transported to/from the FSI camp site (and all applicable related activities) on a daily basis. The mode of transportation will likely be a bus

or van or truck owned and operated by a third party company hired by FSI to provide such service. This posted mode of transportation however is not limited to personal/rented vehicles to be driven by Fellowship Sports, Incorporated staff, coaches and/or volunteers. All participants are to utilize seat belts (where present) and agree to maintain their own seat.

6. I do hereby release, indemnify and hold harmless Fellowship Sports, Incorporated, its agents, volunteers, coaches, employees, representatives, officers, sponsors, advertisers, and assigns, on behalf of myself and my assigns, personal representatives, heirs, and next of kin, from any liability for injury, loss, or damage with respect to all injury, disability, death, loss or damage to my person or personal property arising from or associated with my participation in the Fellowship Sports overnight football camp and/or transportation to/from, whether arising from the negligence of Fellowship Sports, Incorporated or otherwise, to the fullest extent allowed by law.

The above terms are hereby seen and fully understood and the participant hereby signs this waiver as his/her voluntary act with full knowledge that he/she is waiving all claims for injuries or damages arising from or associated with the overnight football camp provided by Fellowship Sports, Incorporated. It is the responsibility of the parent and the participant to gain additional understanding of this document prior to signing.

I, as parent/guardian with legal responsibility for this participant, do consent and agree to his/her release as provided above of all the Releasees, and, for myself, my child and our heirs, assigns, and next of kin, I release and agree to indemnify and hold harmless the Releasees from any and all liabilities incident to my minor child's involvement or participation in these programs as provided above, even if arising from the negligence of the releasees, to the fullest extent permitted by law. I HAVE READ THIS WAIVER OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
